

VERIFIED COMPLAINT FOR PERMANENT INJUNCTION AND PENALTIES


Comes now the Jefferson County Plan Commission, by its attorney, Kristen VandeWater, and pursuant to Jefferson County Zoning Ordinance Section 11.50(C), files its Verified Complaint for Permanent Injunction and Penalties. In support of said Complaint, plaintiff states as follows:

1. That defendants are the owners of a residential building located at 10214 West Deputy Pike Road, Deputy, IN 47230.
2. That said building is situated in Jefferson County, Indiana.
3. That the Jefferson County Zoning Ordinance Section 11.10 (A) provides that "It shall be unlawful to construct, make additions to, demolish, or repair a structure without first filing with the Zoning Enforcement Officer and/or the Secretary of the Plan Commission an application in writing and obtaining a formal improvement location/building permit."
4. Further Section 11.10 (D) provides, inter alia, that "a septic permit approval issued by the Jefferson County Health Department or connection to a municipal sewer system is required" prior to the issuance of a building permit.
5. That defendants have built a residential dwelling on the property situate at 10214 West Deputy Pike Road, Deputy, IN 47230 without obtaining a building permit in violation of the Jefferson County Zoning Ordinance.
6. That defendants have been given written notice of the violation and has been ordered to take action to correct the violation. A copy of said Notice is attached hereto and labeled "Exhibit A".
7. That defendants have failed to comply with the orders of the Zoning Enforcement Officer and have continued with the building and completion of the building

located at 10214 West Deputy Pike Road, Deputy, IN 47230 in violation of the Jefferson County Zoning Ordinance.

WHEREFORE. Plaintiff respectfully requests the issuance of a permanent injunction prohibiting defendants from further using, occupying or permitting the use or occupancy of the building located at 10214 West Deputy Pike Road, Deputy, IN 47230 or from further creating, erecting, changing, converting, altering or enlarging said structure until defendants have fully complied with the Jefferson County Zoning Ordinance.



Investigation by this office has determined that you are in **violation** of the **Jefferson County Zoning Ordinance, Section XXV, stating in part that "No building, or additions to buildings...shall be erected...without first obtaining a zoning permit from the County Building Inspector."**

The violation noted is as follows: *A residence has been constructed on the property. No zoning permit has been issued for this property.*

The following actions should be taken within thirty (30) days of receipt of this notice: *Make application for a zoning permit for the residence.* A copy of the "Requirements for Building Permits" handout is enclosed.

Penalties of \$500 per day are provided for in Section XXVII of the Jefferson County Zoning Ordinance and may be applicable as of that date.
