Please accept this correspondence in response to your inquiries and request for correction of the property identified in Cause No. 39C01-0706-PL-304. It has been brought to my attention that the incorrect address was included in the Complaint, which I filed as attorney for the Jefferson County Plan Commission. The Complaint incorrectly listed 10214 W. Deputy Pike Rd., Deputy, IN 47230 as the address of the property which we allege to have been improved in violation of the Jefferson County Zoning Ordinance.

As you are aware, the Notice of violation that was sent to the Chapos prior to the filing of the Complaint listed the correct Parcel Number of the property of which was intended to be the subject of the Complaint. The Complaint was intended to address the property located at 3677 N. Spry Road, Deputy, IN. I will be filing an Amended Complaint in the coming week to change the address of the property which is the subject of the Complaint from 10214 W. Deputy Pike Rd., Deputy, IN 47230 to 3677 N. Spry Road. However, as I understand that your clients are attempting to obtain financing on the Deputy Pike Address and time is of the essence in correcting this error, I hope that this letter will suffice as acknowledgment of the error until such time as the Amended Complaint can be filed.

Please understand however, that this letter is sent merely as an acknowledgement that the Deputy Pike property was not intended to be the subject of the Complaint of record. It is in no way an acknowledgment or representation concerning whether or not the Deputy Pike property is in compliance with the Jefferson County Zoning Ordinance and I am making no representation as to future actions that may or may not be taken by the Plan Commission as it relates to that property. I can only acknowledge that it was not intended to be the subject of the Complaint filed in the above referenced cause number.
